

SC refuses to stay disqualification process aga

NEW DELHI: The Supreme Court on Friday refused to interfere with the disqualification proceedings initiated against Devender Sherawat, rebel AAP MLA from Bijwasan, by the Delhi Assembly speaker under the anti-defection law.

Declining to stay proceedings by the Delhi Assembly speaker against Sherawat, a vacation

bench of Justice Sanjiv Khanna and BR Gavai remarked: "The matter is pending before the Speaker and why should we interfere?"

Disqualification proceedings against Sherawat were initiated on a complaint by the Aam Aadmi Party, which alleged Sherawat had crossed over to the BJP and had to be disqualified.

Admitting the petition, the speaker issued a notice to Sehrawat, seeking his reply to the

party's petition and indicating the date of hearing for the disposal of matter on June 25.

On Thursday, Sherawat had filed a petition in the Supreme Court, challenging a disqualification notice served on him by the speaker under the anti-defection law.

In his petition, Sehrawat claimed he has been expelled from his party and he had not voluntarily given up his membership. "...therefore the provi-

sions of the anti-defection under Para 2 of the Tenth Schedule of the Constitution of India are not attracted against him. The disqualification proceedings under challenge have preferred under Para 2 (1) of the X Schedule of the Constitution of India which are not maintainable against the present petitioner, who was expelled from the party," the petition said.

Sehrawat claimed he had
